Provide public liability insurance certificate of currency to \$20M with application

Provide detailed trade site plan with application

- The supplied plan must detail the proposed layout of itinerant trading.

Provide copy of Streatrader statement of trade with application (if applicable)

Provide written approval from landowner or relevant road authority attached with application

- Refer to last page of this application form.

Standard Conditions for Itinerant Trading

From Section 19 of Local Law No.1 of 2018 Community Amenity

A person must not undertake itinerant trading:

- 19.3.1 within 300 metres of a permanent business that is selling the same or a similar product, except as an approved trader being part of a stall, festival or other event approved by Council;
- 19.3.2 within 500 metres of a festival or other event approved by Council unless expressly permitted by Council;
- 19.3.3 in a way that obstructs or restricts pedestrian or vehicular traffic;
- 19.3.4 in a way that obstructs or interferes with entry to or exit from any buildings or land;
- 19.3.5 in a way that obstructs or restricts the use of any footpath or road;
- 19.3.6 in an area other than the area specified by Council in their Permit; or
- 19.3.7 in an area designated by Council as belonging to another Itinerant Trader under their Permit.

Permission for itinerant trading on a private property

This permission is required as part of an application for an Itinerant Trading Permit from Rural City of Wangaratta. A permit will be valid for a period of no more than one year, before a new application is required.
